Whereas, the undersigned, have been made aware and understand that to participate in any part of the Camp Langston/Langston-Paul Ranch program, including ATV rides, and freely and voluntarily choose to participate in these activities with full knowledge of these risks:

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained in this Release, the undersigned hereby agree as follows:

1. Waiver of Claims. To waive, release and discharge any and all claims of any kind whatsoever that I may have against Camp Langston/Langston-Paul Ranch and it's shareholders, officers, directors, employees, agents and representatives (all of whom shall hereafter be referred to as the "Releases"), including but not limited to an claim for damages, relief, or compensation which I may have my reason or injury, death , property damage or loss of any kind arising out of my participation in any part of the Camp Langston/Langston-Paul Ranch (including ATV Rides)
2. Hold Harmless: To exempt, absolve, hold harmless and indemnify the Releasees of and from any and all current or future responsibility, liability, duty of care, and/or claims arising out of any injury, death or loss while participating in any part of the Camp Langston/Langston-Paul Ranch program (including ATV Rides), even if such loss, damage injury, or death is the result of negligence on an the part or any or all of the Releasees, or from any other cause. The parents/guardians of any minor named above hereby expressly agree to indemnify and hold harmless the Releasee's may incur as a result of any lawsuit, claim or demand made by said minor against Releasees for any of the activities contemplated herein, to include but limited to any such lawsuit, claim or demand asserted against Releasees after said minor reaches the age of majority.
3. Covenant Not to Sue. I hereby covenant not to sue and agree to never initiate, or be a party to any lawsuit, claim, demand, prosecution or action of law for any damages, relief, or compensation, which I may have by reason or injury, death, damage or loss of any kind whatsoever relating to the negligence on the part of an or all the Releasees arising out of my participation in any part of the Camp Langston/Langston-Paul Ranch program (ATV Rides).
4. Scope. That this Release shall be effective and fully binding upon my heirs, next of kin, executors, administrators, and assigns in the event of my death.
5. Choice of Law. This Release shall be governed by and construed under the laws of Texas and I agree that any legal action or proceeding related to this Release, or arising out of any injury, death, damage or loss as a result of my participation in any part of the Camp Langston/Langston-Paul Ranch program (including ATV Rides) shall be brought only in the District or Superior Court of Titus County of Texas.
